Clerk Swanson distributed an updated draft of the findings of fact and decision regarding the interim use permit application of William J. and Patricia J. Cort. A change of wording, particularly to the description of the nature of the business, was recommended. Clerk Swanson moved, Member Schneider seconded, to approve the amendments to the Subsurface Sewage Treatment Systems ordinance as recommended by Pine County and to recommend to the board that a public hearing on the amendments be scheduled. The motion carried unanimously.
